## Sabine River Ford Pro Rodeo this weekend

World champion bull rider Cody Teel from Kountze is one of several National Finals Rodeo qualifying cowboys chasing the prize money at the 3rd annual Sabine River Ford Pro Rodeo Friday and Saturday, Feb. 5-6, at T-2 Arena in Orange.

"Man, I don't know where all these cowboys are coming from," Chad Havens, event host, said. "We've probably got 30% more contestants entered than we ever have."

The rodeo, held at T-2 Arena, 3810 Old Peveto Road, runs from 7 p.m. until 10 p.m. both nights.

Pre-sale tickets are \$10 at Sabine River Ford, 1601 Green Ave. Tickets will also be available at the gate the nights of the event.

T-2 is a nickname for what is also known as the Tin-Top Arena, because it is covered by a roof. But the structure is open-air, with no walls.

Amie Smith, public relations and marketing manager for Sabine River Ford, says the dealership partnered with T-2 Arena for "this outstanding rodeo event."

"We like to partner with the community to create some fun things for the com-

munity to do. We want to be a part of helping our community have fun," Smith said.

The dealership is no stranger to sponsoring activities in Orange County.

"We support Ducks Unlimited, all the baseball and softball Little Leagues and every school," she said. "Also, Meals on Wheels, Red Cross, United Way and Salvation Army."

"Every vehicle you buy from us, we put money back into Orange County. We want you to be able to live here, shop here and have activities to do here."

The Sabine River Ford Pro Rodeo is sanctioned by the Louisiana Rodeo Cowboys Association, the Cowboy Professional Rodeo Association of Texas and the United Pro Rodeo Association of Dallas.

Youth activities include mutton-busting for children up to 5 years of age and a calf scramble for those under 12. Children should come about 6 p.m. each night to register.

The rodeo program includes barrel racing, saddle bronc riding, bareback bronc riding, bull riding, steer wrestling, tie-down roping

## Fisette following dad's example in BC

To say that Tammi Fisette has spent her life at Bridge City's City Hall wouldn't be entirely accurate.

But it would come close. Her father, Judge Don Peters, was Bridge City's mayor in the late 1990s, after serving more than a decade on city council and city commissions. And then he served a two-decade tenure as Bridge City's municipal judge.

"When I was little, I'd go to City Hall with my dad all the time," she said. "That's pretty much how I got my foot in the door."

"Where my dad went, I went."

Fisette is running in the May 1 election for a fourth two-year term as a City Council member in her hometown. She won her first election in 2015, a few weeks before Judge Peters passed away.

"He was still alive when I first ran, so he got to see that. He was very thankful for that," she said.

Fisette's mom, Patsy Peters, was valedictorian of the first graduating class from Bridge City High School. Tammi and her husband, James Fisette, are both BCHS

grads, and they have two children, Candi Cannon and Keith Fisette.

Candidates for elected city offices and most area school board elections have until 5 p.m. Friday, Feb. 12 to register for a spot on their respective ballots.

Early voting begins April 19.

Insurance man John Nickum has filed to oppose Fisette for the Place 3 seat.

"If I'm blessed enough to get that again, it'll be my fourth term," said Fisette, a leader of the adult Sunday School class at Bridge City's St. Paul's Methodist Church.

As council member, Fisette said she helps neighbors get a fix for their problems.

"I'll get phone calls from citizens and they'll say they have a good concern, say a drainage problem," she said.

"I'll meet them at their house to see what it is and then I get in touch with Mike Lund [public works director], Jerry Jones [city manager] or the Drainage District and say, 'What can we do to help?'"

"That's probably my favor-

## Beauchamp calls for county health department

As Orange County explores avenues to get more COVID-19 vaccinations into the arms of its citizens, two things keep getting in the way.

The county does not have a hospital, an issue for about five years. And it doesn't have a health department.

As it is, Orange County has fallen underneath the coverage of the Hardin County Health Department. Commissioner Theresa Beauchamp wants a health department.

"We [current commissioners] had nothing to do with getting rid of the prior health department," she said. "I know it's expensive, but this has made me have a wakeup call."

"Our people in Orange

County have to use Hardin County as their health department. We need one, even if people's taxes have to go up and I know that's something no one wants to hear."

"And yet, everybody wants to have a health department. When we go over the budget for next year, that we consider having again our own health department."

John Gothia, Orange County Judge, said the county dissolved its prior health department more than 25 years ago.

"It honestly has not been an issue until this," Gothia said, referring to the pandemic. "I'll tell you that not only across the state, but across the country we've seen the inadequacies in health department — not in their service, but in their funding."

"We are looking into possibilities down the road to see if we can do that [have a health department again]. We're looking at grant opportunities. Everything is being looked at to see a way to do that."

"But right now, we're doing the best we can with what we have."

According to rough stats published on a state website, Hardin County has been allocated 3,600 vaccine doses while Orange County has gotten only 1,000.

Joel Ardoin, emergency management coordinator, explained this week that vaccinations listed as being allocated to the Hardin County Health Department are actually being divided 50-50 by Hardin and Orange Counties.

Both counties are also getting allocations specifi-

cally for local pharmacies.

A review of eight weeks of allocation listings on the Texas State Department of Health Services website shows that Orange County pharmacies have received 1,000 doses of vaccines since Dec. 14.

Hardin County pharmacies have received 1,700 doses, according to the lists and Hardin County's Health Department has been allocated 1,900 doses.

If you have those 1,900 doses between the two counties, that means Orange County government has received 950 vaccinations for its citizens and Hardin County Health Department 950.

So that's 1,950 total doses for Orange County citizens either through a county site or private pharmacy.

## Abbott open to reforming his emergency powers

Gov. Greg Abbott said Tuesday he is open to reconsidering his executive powers during state emergencies, a point of contention among some fellow Republicans during the coronavirus pandemic, and that his office is "offering up some legislation ourselves on ways to address this going forward."

"What we are working on — and we've already begun working with legislators — is approaches to make sure we can pre-plan how a response would be done, but it has to

be done in a way that leaves flexibility to move swiftly," Abbott said in an interview with The Texas Tribune.

Abbott spoke with The Tribune the day after his State of the State speech in which he laid out his agenda for the 2021 legislative session, which started last month. As the pandemic has dragged on, some GOP lawmakers have grown uneasy with how aggressively Abbott has used his executive

authority, particularly when it comes to business shutdowns and mask mandates. In the speech, Abbott promised to "continue working with the Legislature to find ways to navigate a pandemic while also allowing businesses to remain open."

Abbott said in the interview that he still wants the governor to have the ability to do things like cut regulations in the time of a disaster, saying there is an "absolute need for speed" in such instances that the legislative process cannot provide. That is especially true, he added, "during a pandemic, when

sometimes it's hours that matters, especially sometimes in responding to demands that are coming from the White House where you basically have a 24-hour time period to respond to it."

"We need to create a structure that will work that accommodates the need for a 24-hour turnaround," Abbott said.

Abbott issued a month-long shutdown of nonessential businesses last spring as the virus was bearing down on Texas. He has since relaxed restrictions and now

The third week of session is coming to a close. The Redistricting Committee has been meeting every day this week to hear testimony from the public and Senate Finance will start meeting next month.

Here are five things happening around the state this week:


• **Texas Gun and Ammo Sales Rise**

Gun and ammo sales are skyrocketing in Texas again this year. Some retailers said their sales doubled in 2020 when compared to 2019 and they're struggling to keep inventory on the shelves. According to a National Shooting Sports Foundation report, there were about 5 million new gun owners in 2020 nationwide. Manufacturers are saying they have enough orders to fill the next three years of production. One man who has been in the gun industry for six years said, "People can buy ammo and shoot ammo faster than they can make it."

• **Southeast Texas Regional Operations Center Vaccine Website**

The Southeast Texas Regional Operations Center (SETROC) has created a new website to allow residents in a five-county region to sign up to be notified when there are COVID-19 vaccines available. The regional operations center serves Orange, Jefferson, Hardin, Jasper, and Newton Counties.

There is a four-step process involved for citizens who want to get vaccinated. First, complete the sign-up form on the SETROC website. That web address is <https://vaccine.beaumonttexas.gov/>. After signing up, you will receive a confirmation email. Importantly, just signing up does not mean you have an appointment. The next communication you receive from SETROC will inform you that you are eligible to schedule a vaccination appointment. This will come as an email and an automated phone call. You can return to the above web address to schedule your appointment and com-

plete necessary paperwork. After you receive the first dose of the vaccine, you will receive a card indicating an approximate time when your next dose is due. A few days prior to that date, you'll receive another email and automated phone call to schedule your second appointment. We are working to stand up additional

vaccine hubs throughout East Texas as quickly as providers are able to source more vaccines.

• **Driver's License Expiration Waiver Ends in April**

The Texas Department of Public Safety is reminding Texans that the waiver that allowed people to put off renewing their expired driver's licenses due to the COVID-19 pandemic is set to expire April 14. If you are driving with an expired license make an appointment to renew your license or renew your license online. Many Texans can use the online renewal process, an easy and safe option that doesn't require you to ever set foot in an office. Currently, driver's license offices are operating on an appointment only basis, so DPS is encouraging Texans to make an appointment as soon as possible to avoid fines or other penalties. You can make an appointment online at <https://dps.texas.gov/DriverLicense>.

• **Cleveland Hospital Selected as COVID-19 Vaccine Hub**

Texas Emergency Hospital in Cleveland has been selected as a vaccination hub by the Texas Department of State Health Services. The first shipment of vaccines were set to arrive at the hospital last week. Vaccines are still being prioritized for Phase 1A and Phase 1B of the roll out. Phase 1A includes front-line healthcare workers, residents at long-term care facilities, home health

workers, and first responders. Phase 1B includes persons 65 and older, or 16 and older with chronic medical conditions. The vaccine is being provided free of cost. To schedule an appointment please call 281-806-7370 or 281-806-7380.

• **Senate Budget Proposal Highlights**

Last week, Senate Finance Chairwoman Jane Nelson filed SB 1, the Senate's base budget. This is the first step in the legislative process for developing the states budget for the next two years. As filed, the bill appropriates \$251.2 billion in All Funds and \$119.7 billion in General Revenue. The bill funds public education and the changes made to the school finance formulas last session including \$3.1 billion to fund enrollment growth and \$1 billion in state aid related to property tax compression. There is also \$8 billion allocated for mental health funding across 24 state agencies, including \$19.5 million to maintain operations for the Texas Child Mental Health Care Consortium. The Texas Department of Transportation would receive \$30.4 billion to address the state's transportation needs, including \$26.4 billion dedicated for highway planning, design, construction and maintenance. This is a great starting point for the budget process and I look forward to working on the budget as a member of the Senate Finance Committee this session.

ite part, receiving those calls and going out and meeting those persons.

"A lot of time, they're easy fixes. And then I go follow up. The communication and the follow up are the best part of this job."

City council members in Bridge City must file for one of six Places, but the members serve the entire city at large instead of geographical districts.

She did that earlier, too, as a member of the Bridge City Volunteer Fire Department, serving with her husband, who served the FD 31 years before retiring as the city's last unpaid fire chief a few years ago.

Tammi went to Lamar-Orange to be certified as an emergency medical tech and worked as an EMT for Bridge City.

"I loved that," she said. "I loved running med calls. It was another way of me giving to my community and meeting people, being able to be by their side at some of their worst moments."

Fisette spent 35 years working at the Bridge City Walmart before moving two years ago to the Orange County Tax Office in downtown Orange.

"I'm loving this [county] job," she said. "It's more opportunity to meet people and it's really helped me with my city council work. I've made lots of good contacts."

"Life is all about helping people. I want to do anything I can to make Bridge City a better place to live."

business operations are based on the proportion of a region's hospital patients being treated for COVID-19. Along the way, some in his party have argued the Legislature should have had more of a say in decisions that affect so many Texans. Some Republicans blasted him for going too far with his executive orders, while many Democrats and local officials criticized him for not going far enough to curb infections.

In the interview, Abbott also addressed the high-powered push to bring casinos to Texas this session. The late GOP megadonor Sheldon Adelson's gambling empire, Las Vegas Sands, has hired nearly 60 lobbyists for the session, hoping to pass legislation that would put the question to voters. In 2015, Abbott said he "wholeheartedly" supported the current restrictions of gambling in Texas, but in the interview Tuesday, Abbott said he wants "to hear where the members are on this."

"One thing I want to do is, when the members get to town, I want to have the opportunity to visit with the members, get a feel for where they are, and importantly they'll have extremely good input from their constituents," Abbott said.

On another potential new revenue source, marijuana legalization, Abbott was more bearish. He said his office is looking at "additional small steps" that can be taken with regard to the drug, "but I don't see any sweeping change [taking] place."

As part of his State of the State speech, Abbott designated five emergency items, or items that lawmakers can vote on within the first 60 days of session. One of them is "election integrity," though Abbott did not provide any details in his address. He elaborated in the interview, saying a "starting point" would be wide-ranging legislation from last session that would have made over two dozen changes to election practices, including making

a felony for Texans to vote when they're ineligible or provide false information on a voter application, even if they do those things unknowingly.

Senate Bill 9, which passed the Senate but never made it to Abbott's desk in 2019, faced stiff opposition from voting rights groups and some county elections officials, who called it voter suppression masked as a security measure and worried that it would carry stiff criminal penalties for common, innocent mistakes.

When it came to elections, Abbott also said there is a "keen focus on mail-in ballots" and how elections were conducted last year in Harris County. Ahead of the November election, Abbott and other state GOP leaders clashed with the county's clerk at the time, Chris Hollins, over his plan to send a mail-in ballot application to every registered voters in the county, among other proposals.

In recent months, many Republicans have called for "election integrity" measures after former President Don-

ald Trump and many of his allies falsely alleged that the 2020 election was stolen from him and that widespread fraud occurred, culminating with Trump supporters storming the U.S. Capitol on Jan. 6 to stop the certification of the election's results. There is no credible evidence of fraud on a level that would have affected the presidential election results.

Election security is the No. 1 legislative priority of the Republican Party of Texas, whose chairman, Allen West, plans to be an aggressive voice at the Capitol this session when it comes to the party's eight priorities. He has also been a critic of some of Abbott's pandemic decisions, fueling speculation that he could challenge the governor in the 2022 primary.

Abbott has kept his distance from the West-led state party, which fired a staffer on Monday after learning that he posted videos on social media of himself at the U.S. Capitol riot last month and shouting about a conspiracy theory at a Washington, D.C., pizzeria.

## Cornyn supports fix for “Dreamers”

With the support of U.S. Sen. John Cornyn — and the arrival of a Democratic president — a new Texas business coalition is launching to advocate for a permanent legislative solution for young people whose parents brought them illegally to the United States as children.

In addition to the state’s senior senator, the Texas Opportunity Coalition includes nearly three dozen chambers of commerce, other economic development groups and institutions of higher learning. They believe the moment is ripe in Washington, D.C., to end the yearslong uncertainty — prompted by executive action — and pass a federal “DREAM Act” that would give permanent legal status to those known as “Dreamers.”

“Clearly the tone has changed, and as you know, President Biden laid out a comprehensive immigration reform [agenda] on day one,” said Woody Hunt, an El Paso developer and major Republican donor who is part of the coalition. “But I think the more practical implication is that you know that you’re gonna get a vote in the Senate, which might’ve not been the case previously.”

The coalition is being anchored by the Texas Business Leadership Council and the Texas Business Immigration Coalition.

The coalition has a key congressional ally in Cornyn, who has been focused on finding a solution for the narrower group of young immigrants who benefitted from the Deferred Action for Childhood Arrivals program. That initiative, which former President Barack Obama announced in 2012, gave certain Dreamers renewable, two-year work permits and protected them from deportation. Obama’s successor, Donald Trump, announced in 2017 that he was phasing out DACA, but the U.S. Supreme Court stepped in last year to save the program.

About 106,000 DACA recipients lived in Texas as of March 2020, and another 86,000 were possibly eligible to apply, according to the Migration Policy Institute

“Dreamers in Texas — they’ve certainly, the last four years, have just been provided a lot of instability and uncertainty, and so we’re taking the position from an employers’ perspective,” Yancy said. “There’s the same uncertainty, instability, for a critical part of our workforce.”

The coalition includes the chambers of commerce in some of the state’s biggest cities — like Austin, El Paso and Fort Worth — as well as several universities, such as the University of North Texas and the University of Texas Rio Grande Valley.

Cornyn has long voiced support for providing a more stable future for the group of young immigrants and voted for it on some occasions. Cornyn said in a Dallas TV interview Sunday he was ready to work with the Biden administration on immigration and that he has “made it pretty clear ... that I think we ought to start with the DACA issue because that’s where I think the greatest consensus lies.”

“I’m ready to act on that and come up with a stable future for these young people who’ve done nothing — they came as children — and I think that that’s a good place to start,” Cornyn told KXAS-TV’s “Lone Star Politics.”


Cornyn is coming off a 2020 reelection bid during which he campaigned on his support for Dreamers, including in one Spanish-language TV ad that said he “strongly supports the legalization of Dreamers.” Democrats and immigration reform advocates say he has a trail of votes that call into question how sincerely he supports legalization. Cornyn has said his thinking on how to approach that group has evolved and he now supports dealing with it on a stand-alone basis.

Opinion on the issue is somewhat divided in the Republican Party, with some DACA opponents arguing that programs to allow the group to stay in the country incentivize illegal immigration. Those opponents include the state’s other U.S. senator, Ted Cruz, who has denounced legislative efforts to help DACA recipients as “amnesty.”

The Senate on Tuesday is set to confirm Biden’s nominee to lead the Department of Homeland Security, Alejandro Mayorkas, despite a push by Cornyn and several other GOP senators to slow down the process by holding an additional hearing with him.

Milton Ted Matkin was born in Shreveport, Louisiana on April 11, 1933. He passed away as a result of advanced dementia in Allen, Texas on January 23, 2021 just three months before his 88th birthday. He worked a number of side jobs at various times including selling real estate, managing rental properties, and maintaining the facilities of a water company. After retiring from Equitable Bag at age 68, he sold dyes to papermills throughout Texas and Louisiana. In his younger years, Ted was an avid fisherman and hunter, and despite efforts by many to get him to play golf, he had no use for “pasture pool” as he called it. He loved working crosswords and playing cards although he hated losing. He especially enjoyed watching the Astros on TV and regardless of the number of channels available, the only ones that mattered were those that played reruns of the Andy Griffith Show, Gunsmoke, and the Western Channel. And, if The Good, The Bad, and The Ugly was on at any time of the day, he would stop what he was doing and watch it as it was after all,

in his words, “the best movie ever made.” Until very late in life, Ted enjoyed mowing and spending time outdoors. He was a connoisseur of chicken fried steak, iced tea, and Blue Bell ice cream. He claimed there was no need for any flavor ice cream other than vanilla, but he did favor cherry vanilla when available. He finally admitted that he liked most any ice cream as long as it was cold. Ted is survived by his son, Neil Matkin; daughter-in-law, Janyth Clemons

# Super Bowl quarterbacks feature old goat, young kid

Sunday's Super Bowl LV at Tampa Bay will feature several historic firsts when the hosting Buccaneers meet the defending world champion Kansas City Chiefs in a game that kicks off a 5:30 p.m. on CBS.

Super Bowl LV will be the first to pit the quarterbacks who won the game in the two preceding seasons, according to this week's issue of USA Today Sports Weekly.

The quarterback match-up between Tampa Bay's Tom Brady, the 43-year-old GOAT, and the Chiefs' 25-year-old Patrick Mahomes, the kid and reigning Super Bowl MVP and surely the next face of the NFL, ought to be epic.

Mahomes was starting kindergarten whenever Brady was starting in his first of an NFL record 10 Super Bowls. The two have split four career meetings, though Brady prevailed in their only post-season match-up when New England won the AFC championship game in 2018, according to the article.

There is much controversy in the media as to which quarterback is the more important to his respective team. Brady has the most seasoning while Mahomes is the most versatile. Brady doesn't have nearly as much raw talent with which to work while Mahomes is surrounded by stars on offense.

Brady will become the first quarterback to participate in the Super Bowl in three different decades and the fourth to start for multiple teams. He joins Craig Morton (Dallas and Denver), Kurt Warner (Rams and Cardinals) and Peyton Manning (Colts and Denver). Only Manning led different franchises to Super Bowl wins.

Brady has started in a record 14 championship games, twice as many as the next man on the list—Joe Montana—and has won 10, according to the article.

In seven post-season starts, Mahomes has thrown 17 touchdown passes (three in the AFC championship game) with only two interceptions.

Tampa Bay's Bruce Arians and the Chiefs' Andy Reid are the oldest combined head coaching match-up in Super Bowl history.

Tight end Travis Kelce and speedy wide receiver Tyreek Hill

# Fresh and Saltwater Bite Improves

The combination of some seriously low tides and a little more north wind than needed are keeping Sabine Lake clarity on the muddy side, but the trout are apparently adapting to successfully hunting down their next meal. The most encouraging aspect is that most of these fish are in the two to three pound class!

The big trout are still missing in action, but improving numbers of solid fish is something to get excited about. It was a long time coming.

I have only had two opportunities to sample the bite recently, but did pretty well on both trips. I owe my success to a couple of local anglers that don't want their names mentioned and I don't know that I would have caught a single fish without the tip.

Simply suggesting that I fish slower than usual and stay in three to five feet of water would have helped, but I would probably have struck out anyway had they not shared a couple of starting spots. Both were also quick to remind me that the fish were there, but they were feeding in tight schools and I might have to wait them out.

When you have nothing else going, waiting them out is not a problem. It was also helpful to know that they were catching their fish on Corky Fat Boys and Devils. I initially thought I was a day or two late as my lure disappeared almost as soon as it hit the water. That does not do a lot for your confidence.

I was down to about thirty remaining minutes of little else than practice casting when the first trout finally just crushed my Corky. The second fish did the same thing which indicated that they were really hungry or that

there were a lot of them competing for the same meal. I think it was a little of both for about thirty minutes.

I hit three or four similar spots on the way back and never got the first strike. Two days later I very nearly waited too long before discovering that the trout had moved less than a hundred yards down the same non-

descript stretch of shoreline.

I actually found those fish drifting a GULP curly tail under a cork in hopes of catching a red or two. When I caught the first trout I switched over to the Corky and for some reason they wanted the Devil more than the Fat

# Texas Abandoned Crab Trap Removal Dates Set for 2021

AUSTIN —Each February for 19 years, countless volunteers spend 10 days on the water along the Texas coastline searching the bays for abandoned crab traps left to foul shrimpers' nets, snag anglers' lines, "ghost fish," and create unsightly views. To date, they've hauled off more than 38,000 of these derelict traps.

From February 19th through the 28th, Texas coastal waters will be closed to crabbing with wire mesh crab traps to facilitate the annual volunteer crab trap cleanup. Any traps left in bays — including traps tied to docks — will be assumed abandoned and considered "litter" under state law. This allows volunteers to legally remove any crab traps they find.

Volunteers are needed to assist in the coast-wide effort to remove the numerous traps that have been lost or abandoned since last year's cleanup. Volunteers are urged to wear masks and keep socially distance from



those not in your household when appropriate. In an effort to facilitate volunteer efforts, several sites along the coast will have clean-up events on February 20 from 8am until noon. These sites are denoted as "facilitated" in the list below. Registration with partner organizations may be required. Additionally, at all sites, dumpsters or collection areas marked with banners will be available to receive traps for the duration

of the closure. Volunteers may focus their efforts on Feb. 20 or work at their own pace anytime during the closure, but traps cannot be removed prior to Feb. 19 or after Feb. 28.

The Coastal Conservation Association Texas, Coastal Bend Bays & Estuaries Program, Galveston Bay Foundation, San Antonio Bay Partnership, and the U.S. Fish and Wildlife Service are providing continued support

to the crab trap removal program. Numerous other organizations and companies also are volunteering their services.

To participate, volunteers may pick up free tarps, gloves, face coverings, and additional information at their local TPWD Coastal Fisheries field stations. TPWD requests that volunteers who remove traps record and submit information about the number of traps

they collect as well as documenting any sightings of diamondback terrapins.

All other legal means of crabbing will not be affected during the closure period for wire crab traps. For more information, contact your local TPWD Coastal Fisheries office or Holly Grand at (361) 825-3993 or crabtrap@tpwd.texas.gov.

# Wildlife experts ask for public help in reporting bat mortality events

AUSTIN – Last winter, White-nose Syndrome (WNS) was detected in bats in 18 counties in central Texas and the disease has continued to spread. The Texas Parks and Wildlife Department (TPWD) is monitoring its progression through the state and is asking for the public's help to understand how WNS is affecting vul-

nerable bat populations.

"Last year, we received reports of bats dying or acting strange from around the state" said Nathan Fuller, a TPWD bat biologist. "Unfortunately, we expect the same thing to happen this winter and we are asking Texans to be on the lookout for distressed bats. Texas is a big state and we can monitor bats much more effectively with more eyes out there looking for bats."

WNS is a fungal disease that affects hibernating bats during the winter. As the name suggests, WNS presents as a white, fungal growth on the ears, nose and wings of hibernating bats. Researchers believe that the fungus that causes WNS, *Pseudogymnoascus destructans*, was inadvertently introduced to North America from Europe sometime in the mid-2000s.

Fuller says that winter is a dangerous time for bats as, after hibernating for a few months, bats with WNS start to run out of fat in January or February.

"Once this happens, bats often leave their roosts in search of food or as an attempt to escape the disease and unfortunately, the animals usually don't survive," said Fuller. "However, if we know where bats are in the most trouble, we can enact measures to protect the survivors and give them a chance to recover."

The pathogen that causes WNS is thought to be spread by bats through contact with other bats or contact with

contaminated surfaces. The fungus grows optimally in low temperatures and as a result, remains in bat hibernation sites long after they have left their roosts in the spring.

Since the first observation of WNS in upstate New York in 2006, the disease has spread throughout North America. Wildlife experts believe that millions of bats have succumbed to the disease. The actual number is unknown because of the difficulties associated with monitoring bat populations. The disease is not a risk to humans.

Bats are a critical part of the Texas ecosystem, with more than 30 species of bats calling the state home.

"Bats provide billions of dollars in pest control services by eating insects that damage crops," Fuller said. "Without bats, food costs could increase. They are also sensitive to environmental contaminants and other damage and so they can act as indicators of ecosystem health and function."

TPWD is asking the public

to send reports of dead bats that are found to wns@tpwd.texas.gov. Those sending a report are asked to include a general location and, if pos-

sible, a photograph. Biologists say that people should not handle live bats or bat carcasses with bare hands.

# Big fishing opportunities found in small windows

How many times have you had it happen to you? After hours of fishing, struggling, changing baits, and changing tactics it finally happens, the fish finally decide to cooperate and all is right with the world again. That brief period of euphoria wipes away all the memories of cold boring hours spent probing empty acres of water; it's the opportunity we all search for yet only few find on a consistent basis. Those few fishermen who routinely find these brief periods where fish go on rampages that the average guy can only dream of rapidly reach mythic status in the fishing community. The "underground" of the fishing world buzzes with the stories of these fishermen, exploits surrounding sessions when every cast was met with a bone jarring strike circulate

at the boat shows and each time the story is told the stringer always gets bigger. Every coastal angler dreams of fishing trips like these but most don't understand what it takes to achieve these results.

If you ever get a chance to talk to the really good fishermen along the Texas coast you will find that most of them are very detail oriented and they keep some sort of

records. The records consist of all the obvious things like tides, temps, weather along with bottom structure, available bait, and a few others. The records offer up valuable history that can help anglers find a consistent fish catching pattern. During the winter months those fish catching patterns don't last very long during the day, all the factors tend to align themselves for a brief period

of time and that's when memories are made. These small windows of opportunity are the key to being successful during the tough stretches in January and February because these windows are the smallest of the year. Many anglers fish all day in hopes of finding fish while others make shorter trips based on the patterns from past years. 9 times out of 10 the guy with the known

pattern on his side will catch more and bigger fish.

On Sabine and Calcasieu the patterns hold the same much like they do farther down the coast, warmer water on incoming tides late in the day are a favorite of many. The combination of these factors can be extraordinary, especially when you know you can count on the bite being consistent. The afternoon incoming pattern works well and is probably the favorite but what happens when you don't have these conditions? The outgoing tide can also provide some warm water onto productive flats provided you have some marsh areas nearby. Water from the back lakes and marshes heats up during the day and is usually protected so it holds heat for long periods of time. On the outgoing tide this warmer water rushes out onto the flats and bars carrying with it bait fish and other food that speckled trout, redbfish, and flounder thrive on. These sudden temperature changes coupled with tidal movement will often kick start the fish into feeding mode and if you happen to

be there at that time you may just be the subject of the next great fish story.

I have been on the fortunate end of career days using both the incoming and outgoing tides during the winter and these trips help erase the thoughts of the bad days which we all inevitably suffer through. All you can do as a fisherman is to put the most odds in your favor and put your time in on the water. As unpredictable as the winter can be it's awful nice to know that there is the possibility of predicting when and where the fish will bite.

Looking at February the first thing that comes to mind is run off from the lakes to the north and what kind of effect it will have on Sabine and Calcasieu. As it stands right now all the water levels on the lakes are well below normal and that means stable conditions and saltier water for the spring. Any type of consistent pattern will be a welcome blessing for anglers testing Sabine or Calcasieu this spring, who knows what kind of great fishing awaits.

Hill have both exceeded 100 receiving yards in each of the Chiefs playoff games this season.

Hill, reportedly the fastest NFL player with 4.27 speed in the 40, burned Tampa Bay cornerback Carlton Davis III for more than 269 yards and multiple touchdowns, doing most of the damage before the first quarter was over when the two teams met in Week 12 and the Chiefs won 27-24 at Tampa Bay. Rusty Frederick and his daughters, Madelyn and Olivia recently took advantage of one of our warmer afternoons and really did a number on some very nice redfish. "I had them drifting with a cork and they both won multiple tug of wars with some very nice fish," bragged their deservedly pumped Dad.

Rusty added that the reds were feeding in the same place he had been catching trout. "The trout may have been there as well, said Rusty, "but I quickly became the net boy and head cheerleader."

I knew Rusty and his Dad could fish with anybody, but it now looks like the females

in the family have a gift for catching fish as well. Those are the kind of days you never forget.

I don't think that even this cold front will move the big bass on Toledo Bend. There are a lot of sows that have already moved into eight to twelve feet of water and I don't see the lake level falling enough to move them.

We got in less than six hours of fishing one day last week and still got some swings at some very nice fish. I caught nothing over six pounds, but my host got a "sure enough" double digit fish to the surface and managed to boat another in the eight pound class.

He had been catching all of his fish on a three eighths-ounce black, blue and brown jig, but we caught every fish on a half-ounce single spin spinnerbait. Because there was no grass on his favorite spots, the slower fall seemed to help.

Hope I can give it another try in the very near future!
