# Couty pays tribute to local Workforce

Orange County Commissioners Court has declared February as Southeast Texas Workforce Month and the county's economic development director said there's reason to celebrate.

Megan Romero Layne, the EDC director, told the court just this month, the county added 80 new healthcare jobs with the opening of Christus Hospital-Orange.

The EDC in Orange County currenting has \$12.5 billion in construction and planning projects, with another \$73 billion in construction and planning for the rest of Southeast Texas.

Also, Lamar State College-Orange is now working with the Texas Federation for Advanced Manu-

facturing Education to form a "pipeline" of skilled workers into the work force. With a new LSCO program that now has open enrollment for the fall, students will be able to get 60 college credit hours and two years of experience on the job.

In addition, Golden Triangle Polymers, the new \$8.5 billion chemical plant under construction, will have another Local First job fair on March 7. The plant is a joint venture of Chevron Phillips and Qatar Entergy. Part of the county's tax abatement agreement included the designating company money for the Local First program to help local residents and business owners get jobs and contracts during the construction.

# Precinct 2 candidates talk experience, serving public

The three Republican candidates for Precinct 2 constable touted their long experience in law enforcement as reasons voters should elect them in the March 4 primary rac-

The candidates, incumbent Jeremiah Gunter and challengers David C. Bailey and Harold Hass, are running for the Republican nomination. Because no Democrats are running for local offices, the winner of the primary will run unopposed in the November general election.

Last week, the Orange County Republican Party held a public forum at Mauriceville Elementary School with the candidates so the public could get to know them. Questions were submitted before the forum and candidates were given the ques-



A similar forum for the four Republican candidates for Orange County sheriff will be this Thursday, February 8, 6:30 p.m. at Little Cypress Elementary School, 5723 Meeks Drive in Orange. Candidates are incumbent Jimmy Lane Mooney, who is seeking his second fouryear term. He is being challenged by veteran law officers Ron Dischler, Mike Sanchez, and Bobby

Smith. In Precinct 2 Gunter is finishing his first fouryear term in the office. He



said he moved to Mauriceville with his parents when he was a child in 1986. He has 23 years of law enforcement experi-Hass said he and his

wife moved to Orange County 48 years ago when he took a job with the Orange Police Department. He is now in his 70s and has also worked for the Orange County Sheriff's Office under different sheriffs and has years of training. He has never held public office before. Records show he has previously run for office, including the constable's position.

Bailey said he has been in the Mauriceville area for more than 60 years with he and his children graduating from the Little Cypress-Mauriceville

High School. He has served in various positions in the Orange County Sheriff's Office through the years, including serving as chief deputy, an administrative position.

Records also show Bai-

Former President Donald Trump is bringing his MAGA star power to Orange County by endorsing David Covey of Mauriceville, who is seeking to beat Dade Phelan of Beaumont for the District 21 seat in the Texas House of Representatives.

Both are Republicans running against each other and Alicia Davis of Jasper County. Phelan, who is seeking his fifth term, has never before drawn an opponent.

Phelan not only represents all of Orange County, part of Beaumont in Jefferson County and LAUREN MCGAUGHY part of Jasper County, he has served two, two-year terms as the Texas Speaker of the House, considered one of the most powerful positions in state government.

Phelan this past summer oversaw impeachment hearings against Texas Attorney General Ken Paxton. Though the Texas House voted to im-

# Bills to fight Paxton's case top \$700,000

The Texas Tribune A private law firm has charged the state nearly \$700,000 to defend the Office of Texas Attorney General Ken Paxton against the whistleblower lawsuit that led to his impeachment.

According to documents The Texas Newsroom obtained through a public information request, Houston-based Lewis Brisbois Bisgaard & Smith filed an invoice on Jan. 1 that brought its charges to date

\$697,658.63. Including other charges, the state has been billed just more than \$700,000 to fight the case over more than three years. These costs are in addition to, and separate from, those incurred during Paxton's impeachment trial.

The lead lawyer on the case, William Helfand, is

charging \$540 an hour. The January invoice, which detailed \$30,637 in charges, included time spent drafting arguments that Paxton and his aides should not have to testify under oath.

Paxton's agency hired the outside law firm in 2020, shortly after four former senior employees sued for wrongful termination under state whis-

peach Paxton, the Texas Senate did not. In the Texas House, 60 of 85 Republicans voted in favor of the impeachment.

Paxton has been a strong supporter of Trump and is now endorsing Covey against Phelan.

The Texas Tribune, a non-profit online publication known for covering Texas government and politics, this week described Phelan as the "No. 1 enemy of Texas' farright conservatives" because of the impeachment hearing. The publication pointed out the political divide even though Phelan has led the passage of some of the most conservative bills in state history.

Trump's written endorsement statement reads, with his capitalization, "David Covey is running against Dade Phelan, the Speaker of the Texas House of Representatives, who led the Fraudulent Impeachment of the recently re-elected, in a landslide Attorney General of Texas, Ken Paxton.

"David is an American First Conservative who will Secure the Border, Restore Election Integrity, Protect our Families and

Military/Vets, and Defend our under siege Second Amendment.

"Last week Dade Phelan said 'I voted for President Trump twice for President, and I'm going to vote for him a third time. I think he's going to be the nominee.' Words, however, do not mitigate the Absolute Embarrassment Speaker Phelan inflicted upon the State of Texas and Our Great Republican Party!

"Therefore, David Covey has my Complete and Total Endorsement for Texas' 21st State House District--He will never let you down!"

Phelan in a statement said he has supported the former president in the past and will continue to support him this year. tleblower laws. They accused Paxton of forcing them out of their jobs after they reported him to the FBI for alleged corrup-

The allegations eventually led the Texas House to impeach Paxton for alleged bribery and abuse of office. He was acquitted after a trial in the Senate.

But the whistleblower lawsuit has con-

Spokespeople for Paxton's agency did not respond to requests for comment. But the attorney general himself has repeatedly weighed in on the cost of the lawsuit.

In an attempt to toss the lawsuit last month, Paxton said it had become too costly for taxpayers and distracting for his agency. He wrote in a statement that he wants to refocus "the entirety of agency expertise and resources to our urgent legal initiatives."

It's likely Paxton hired the private firm to avoid conflict of interest concerns that would have been raised if his own agency lawyers had taken on the case. The same

firm also produced a paper that purported to clear Paxton of the corruption that the whistleblowers raised.

Paxton has denied all wrongdoing in the

In addition to Lewis Brisbois, Paxton's agency has brought on other private firms to handle other aspects of the case. According to the new invoices, it hired the Kingsland-based firm Brown, Lacallade & Lange to attend a hearing in December.

That day cost the state \$1,375.

Another private firm billed \$2,876 in December and January, according to the newly-released invoices.

This brings the grand total to defend Paxton's agency in the case to just more than \$700,500.

The state of Texas also incurred costs to prosecute Paxton in his impeachment case. The investigation and trial cost at least \$4.2 million. The attorney general tapped his campaign funds to pay his attorneys \$2.3 million to defend him against the charges, according to The Texas Tribune.

The impeachment procedures against Paxton have split the Orange County Republican Party and the Texas Republican Party. Besides having the endorsement of Trump, Paxton has endorsed Covey and even visited Roberts Meat Market in Orange to meet with the candidate and other local Republicans. Also, Lieutenant Governor Dan Patrick and Agriculture Commissioner Sid Miller are endorsing Phelan.

Phelan has the endorsement of Rick Perry, a longtime Republican governor of Texas who served in Trump's cabinet as Secretary of the Department of Energy. Locally, Billy Rowles, the popular former sheriff of Jasper County has endorsed Phelan. He has also been endorsed by the National Rifle

Association and the Texas Department of Public Safety Officers Association.

On Tuesday, Phelan came out with a new political ad outlining reasons for the impeachment, which included allegations of Paxton using his office to help a rich donor and friend. The allegations included information about an extramarital affair Paxton

The impeachment allegations came after former top lawyers in Paxton's office sued under the state whistle-blowers law that they were wrongly terminated after giving their allegations against Paxton to the FBI. Lower courts decided in favor of the whistle-blowers and the case is now with the Texas Supreme Court.

ley has run for public office in the past and won a seat on the Orange City Council three years ago. He has not filed for reelection to that spot and his term expires in

On a question concerning the roles of a constable in Texas, Bailey said the constable serves as bailiff for the precinct's justice of the peace court and serves papers for the IP court. The constable also works patrol, does traffic stops, helps in school ones and works with all other law enforcement agencies. He said he is retired and will not need to take outside jobs. However, as constable, he can take on extra pay to work for security at events like football games or provide funeral escorts.

Hass said Orange County has full-time, not part-time constables and he will be a full-time constable. He will quit his construction job in Beaumont if elected and work more than 40 hours a week to the constable's work.

Gunter said he, as constable, not only serves warrants and legal papers for Orange County, but also for other counties and law agencies. Last year, he served more than 870 legal papers, from about 300. He said he works 40 hours a week and is available at any time for people who need him.

However, Gunter, who is the youngest of the candidates and the only one not retired, said the county does not pay for his car expenses in the job and he spends \$288 a week for the car. He said that leaves him with \$648 to support his family of wife, two sons and two stepdaughters. He said he will continue to do extra jobs to support his

family and has never asked the county for a larger salary.

Concerning one question about having a criminal record, Bailey said he has never been convicted of a criminal offense and is up-to-date on his Texas law enforcement certification. He said he was not fired from the sheriff's office in the past, but retired after a new sheriff was elected and took office. Bailey served as chief deputy in the

Also, Gunter denied an accusation that he had sued Orange County and used up years of work from the county attorney's office. He said he filed a grievance with a previous sheriff after he was terminated when a supervisor lied about him. The grievance went through the legal process with the deputies union and the opinion came in his favor that he was wrongly terminated. He said he has never sued the

Hass said he worked under Sheriff Huel Fontenot, who took office in 1989 and served until 1997. Hass said under the next sheriff, he went from working as a narcotics investigator to being on patrol. He said he doesn't know why, but the mechanic for the office told him about a request to turn back the odometer of a vehicle owned by Texas Parks and Wildlife for game warden patrol.

Hass said he followed protocol by reporting the complaint to the chief deputy at the time and later talked to the FBI about it. He said officials in the sheriff's office blamed him for talking to the FBI, so he resigned. He said he was not fired.





### **County business**

Layne also updated Commissioners Court on the tax abatement deal with Olson Engineering in Bridge City which expanded under a tax abatement agreement. She said the company went from a property value of about \$295,000 to \$3.7 million, adding a little more than \$3.4 million in taxable property. The company added five more jobs this year.

She said the county is now in the third year of the tax abatement policy and the county will reimbure the company the \$19,590 in county property taxes that were paid this year, which is 100 percent.

Also during the meeting, the court approved three more plat changes for housing development in the county. One was for subdividing 2.7 acres into two lots of the Dowers Addition in Precinct 4.

Another was for the Ravenclaw subdivision in Precinct 2 to subdivide 8.18 acres into two lots, plus the replat of 5 acres of Verrett Acres in Precinct 3. County Engineer Corey Oldbury said the plats met all county standards and were approved by the Orange County Drainage District.

County Judge John Gothia thanked Maintenance Director Curt Guidry and his crew for moving back the court's platform and podium from the wall. He said court members had only about three inches to push back their chairs when standing for things like the prayer, pledge, and proclamations.

In a report to the court, Guidry said crews were fixing things at the new Elm Avenue building. It was originally part of the old Southwest Bell Telephone offices and later used by the First United Methodist Church. The church last year donated it to the county to be used to help house emergency responders coming here after disasters like hurricanes.

The court approved a number of payments for bills, including \$105,875 to the Texas Association of Counties for the

medical, dental and life insurance for county employees, plus another \$79,500 to Amwins Group Benefits for insurance of county retirees age 65 and older.

Another \$21,653 went for contract payments due in February, plus \$26,142 to Shaumburg and Polk engineering and planning for drainage improvements through the Texas General Land Office disaster recovery grants.

The court extended an interlocal agreement between the county and the city of Pine Forest in Precinct 4 for a project reworking drainage ditches in the Sugar Mill Road area west of Ten Mile Creek.

The sheriff's office received permission to use \$11,770 from contingency funds to pay for an increase in price from three Ford Explorers that had been back-ordered since 2022. Judge Gothia said the court had to approve the expen-

County Engineer Oldbury was given permission to hire a new office manager for the Road and Bridge Department on February 20 rather than on March 4. The current manager is retiring at the end of March. Oldbury said the other employee in the office has had to be off work for approved reasons.

Also, the court approved spending \$14,585 for switches for the updated security camera system at the Orange County Expo Center, which also serves as the county's emergency operations center during hurricanes and other disasters. The system has 136 security cameras.

The county will aos seek grant proposals to oversee the administration services for flood improvements through the Texas Water Development Board, along with selecting an engineering service for the grant projects. The court appointed a committee to review the proposals.



#### A BORDER SECURITY BILL **WORTH PASSING**

The Senate bill has reforms Trump never came close to getting. Despite weeks working with **Dem**ocrats to shape a compromise on illegal migration that also bolsters national security threats, the **Trump-dominated GOP** intends to do nothing until Election Day. Do Republicans want to better secure the U.S. border, or do they want to keep what has become an **open sore** festering for another year as an election issue? James Lankford, who negotiated for the GOP, deserves thanks for digging into the policy nuances and writing a bill that Mr. Trump never came close to getting when he was President. If Republicans reject this bill, they will hand Democrats an argument that the GOP wants border chaos that they can exploit as a campaign issue. The chaos will continue for at least another year. #### STOMACH CANCER KILLED **TOBY KEITH**

Country singer-songwriter **Toby Keith** died at age 62 Monday from stomach cancer, a relatively rare form of cancer that is usually discovered in a person's late 60's but can also strike younger people. **Keith** died after battling the disease for three years. The Academy of Country Music Awards, which named Keith entertainer of the year twice, in 2002 and 2003, recapped his spectacular run with the institution, which amounted to 15 awards. "With worldwide sales of more than 40 million albums, he built an exceptional career on well-sung ballads, barroom sing-alongs, and patriotic anthems, as well as heartfelt songwriting, for which he was inducted into the **Songwriters Hall of Fame** as well as received the National Medal of Arts. The ACM said in a statement posted on social media, "Keith wrote the vast majority of his no. 1 hits and had a chart-topping single every year for 20 consecutive





# Big drum offer up full pull

Some of the angling faithful have taken advantage of the lack of on the water participation from most fishermen, big trout hunters have spent the past weeks waist deep in chilly water snatching stud trout from nearly every venue along the coast. Bass fishermen have enjoyed some incredible catches already this spring; double digit bass seem to be popping up anywhere and everywhere.

Big trout and big bass certainly steal the thunder for the most part at this time of the year but they aren't the only big fish game in town. Right now there are some genuine huge fish patrolling the near shore waters and only a few people actually take advantage of what could be the best opportunity all year to take a bona fide giant fish.

The jetty systems at both Sabine and Calcasieu are known for spitting out some huge redfish and black drum. These fish routinely top the 40 pound mark and occasionally go much bigger. This style of fishing is nothing close to finesse and requires some degree of patience along with some good gear. If catching the biggest fish of your life interests you then read on.

Having these giant fish so close is not a new concept, for many years local anglers have gone to the rocks to tackle these huge fish. In a yearly ritual both fish and fishermen make their way to the passes, each for different reasons. The spring currents and water temps coax the redfish and black drum to follow their instincts and heed the call of nature; this is what brings them within most anglers reach. These big spawning size fish make an annual predictable migration that only few fishermen take full advantage of.

Once you decide to head for the jetties or the channel to tackle one of these awesome fish you need to be sure to gear up accordingly. Light action rods meant for chunking soft plastics and topwaters need not apply here, you can catch these fish on those lighter rods but they are certainly not preferred. A quality rod made to handle 20 pound test monofilament is a good place to start, the stiffer the action the better.

Fish of this size are not delicate; they are pulling machines and require the angler to put plenty of pressure on them. A quality reel capable of storing a good amount of 15 to 20 pound test mono is the other piece of the equation. The old tried and true wide framed Ambassador or Calcutta are favorites for this duty. Good drags on reels are also a must as these fish will certainly put them to the test.

Rigging up for these fish consists of a basics fish finder rig, also known as a Carolina rig. On the terminal end of the rig it's preferable to have some heavy shock leader or fluorocarbon for extra abrasion protection from rocks, shell, or gill plates. The big 5/0 circle, live bait, or J style hooks are tailor made for this application, they need little or no pressure for a hook set and make releasing these big fish much easier as they tend to lodge in the corner of the mouth rather than being swallowed. Any number of live or dead baits will work on these fish, shrimp, crab, mullet, or shad area all proven producers.

Now that you are all rigged up it's time to concentrate on an area, deeper holes along the jetty wall and along the channel are without a doubt the best places to start. One of my personal favorite places to use this technique is around Lighthouse Cove; the shallow shell that lines the drop off into the ship channel is a magnet for these big fish.

The opportunity to catch 40 plus inch fish that weigh near 50 pounds is awfully exciting, I don't care who you are. A couple of reminders to think about take caution fishing around the channel or the jetty system because the ship traffic can be dangerous if you are not careful.

Also take care of these huge fish when you catch them, most will be too large to keep so take great care when releasing them so they can live another day. Now that you have the low down on catching those huge fish get out there and get your line and arms stretched out.

#### Sabine Lake

FAIR. 54 degrees. Sabine Lake is stained after the recent cold fronts. Limits of redfish, drum and sheepshead in the Bessie Heights area and ditches leading into the marsh in 6-8 feet of water Carolina rigged shrimp, or live shrimp with popping cork. Fish are on the Neches River on shell banks, points and drops. When the winds are blowing out the south the bite improves in the lake and ICW. North Levee wall producing nice trout early in the morning on Carolina rigged live shrimp or live shrimp under a popping cork. ICW holds limits of redfish, sheepshead and drum popping cork with live shrimp, or Carolina live shrimp off the bottom. ICW slot redfish 5 inch plastics 1/8 ounce jighead morning glory chartreuse.

#### Bolivar

FAIR. 44 degrees. Believe it or not, there have been catches of catfish, bass and redfish in East Bay due to the freshwater runoff. Surf producing catches of black drum, red drum, a few speckled trout and sporadic sheepshead. Surf at bolivar flats producing catches of sand sharks and spinners. Report by North Jetty Bait Camp.

#### • Trinity Bay

SLOW. 56 degrees. What had been steady action has come to a halt due to the freshwater runoff from the recent rains. Report by Captain David Dillman, Galveston Bay Charter Fishing. Major water event with San Jacinto and Trinity rivers dumping heavily. Redfish, being more durable, are bouncing back quickly around rocks and water movement being caught on swimbaits and gulp baits. Sheephead are in abundance around docks and pilings with barnacles free lining shrimp along with black drum. Trout will bounce back after returning to their fine waters monitoring the salinity levels. Flounder can be caught on drains dumping from muddy lakes on live shrimp and gulp baits. Report by Captain Zackary Scott, Zack Attack Fishing.

#### East Galveston Bay

FAIR. 50 degrees. Fishing has been slow due to freshwater runoff and the bay is off colored. Report by Captain David Dillman, Galveston Bay Charter. Surface water temperature rose to 58 degrees, water clarity stained for the most part. Our success remains back in the marsh/

bayou areas where one can get some protection from the Strong North wind and wave action. This Redfish bite has still been consistent in areas where good current flow has bait up against the shorelines/ grass lines in 1 to 3 feet of water around oyster shells on Wac Attack Tails in Chartreuse, fished with 1/8 oz heads, as well as fished under a Fish Smack popping cork, with an 18" leader. The trout have preferred an eratic presentation with pauses, targeting deeper pockets close to channel bends/deeper drops with shell, triggering the most bites. The lighter the jig head the better, determined by the wind and current, and tails without paddles, performing the best. Water has warmed this week and the fish are more active

compared to last week, we just need the winds to cease a little to allow us to fish more of our winter time areas. Report by Captain Jeff Brandon, Get the Net Guide Services, LLC.

#### Galveston Bay

SLOW. 58 degrees. Lots of freshwater runoff in the bay. Few catches of black drums and redfish reported from deeper channels on live shrimp. Report by Captain David Dillman, Galveston Bay Charter Fishing.

#### West Galveston Bay

SLOW. 56 degrees. Fishing has been slow, although the water remains in good shape in the middle of the bay. Tides are low, but once they come back up, look for the fishing to pick up. Report by Captain David Dillman, Galveston Bay Charter Fishing.







# TPW Approves Statewide Changes to Spotted Seatrout regulations

AUSTIN - The Texas Parks and Wildlife (TPW) Commission approved proposed rule changes to bag and size limits for spotted seatrout during its Jan. 25 meeting.

Spotted seatrout bag and size limits approved by the commission include:

- Three fish daily bag limit per angler
- A minimum size of 15 inches and a maximum size limit of 20 inches
- One oversized trout greater than 30 inches allowed as part of daily bag limit

These rules will go into effect as soon as possible, with notice on the actual dates to be provided when that timeframe is known. Additionally, commis-

sioners granted permission to publish a proposal to create a tag system allowing for the take of oversized trout (greater than 30 inches), including one bonus tag per year, for an associated fee. The commission will pursue future public input and consider adoption of the proposed tag system in March.

The changes to bag and size limits follow emer-

gency and temporary regulations enacted after Texas' 2021 winter freeze and are based on multiple scoping efforts, including surveys and input from recreational anglers and guides. 

# Love Despite Difference

"Oh, my. You have to pull over!" the woman pleaded from the passenger seat. "My head hurts."

Her head hurt because my son was screaming his head off.

Rewind five minutes to when I first pulled up to her apartment building, towing a fussing baby. My oneyear-old hates the car, but the ride to church is short (usually). This morning we took a detour, and he knew it. Complaints mounted to cries as we waited for the woman and her son to come outside.

She's a single mom, and he's a high school boy. They're refugees, new to our country, culture, language, and (as I later realized) traffic laws. Neither of them has an American driver's license, but what they do have is a church our church. Just a few months back, when they took vows before the congregation and became members, others started coordinating rides for them each Sunday.

So there they were, in my car. And there we all were, listening to a baby wail at soaring decibels. His cries had become fever-pitch screams when two relative strangers, with skin far darker than mom's or dad's, opened the doors. I flung crackers and toys into the backseat, but there was only so much I could do while driving.

Then she had an idea: "Put him on your lap! Put him on —"



Before she could finish, her son began to protest, explaining how "they don't do that here." I nodded vigorously, even gratefully, as he spoke, my own voice wobbling between saying sorry and making shushing sounds. "Well, in our country," she replied, "the police would pull you over. They would think you stole this

#### Lost in One-Anothers

It's far easier only to drive people you (and your shrieking baby) already know well to church. Just like it's far easier only to invite like-minded people into your home, only to comfort or encourage those you understand, only to forgive the friends you want to keep around. It's far easier — and far less like the "one-anothers" of Scrip-

Upwards of fifty times in the New Testament, we read of particular ways we are to treat "one another." As our eyes speed over these commands — all the so-called "one-anothers" our mind is quick to ac-

knowledge two things. We

understand what is commanded (verb), and we understand that it's commanded of us (subject). We know we should

- "love one another" (Romans 12:10).
- · "welcome one another" (Romans 15:7),
- "[forgive] one another" (Ephesians 4:32),
- "comfort one another" (2 Corinthians 13:11), "serve one another"
- (Galatians 5:13).
- "build one another up" (1 Thessalonians 5:11).

Without realizing it, though, have we missed the who at the end of each of these commands? Have we neglected to even ask who it is that God commands us to encourage, love, welcome, forgive, comfort, serve, build up? When we do not ask God to define "one another" for us, we slip into choosing those people for ourselves. And the people we choose tend to be the people we like. And the people we like tend to be the people like us.

But have we really obeyed the one-anothers when we apply them only to those we

ble our way through the one-anothers, have we been obeying them, or have we simply been spending all our love on all our favorite people? Apart from that chaotic car ride, I can't think of a time when it was truly difficult to press into the one-anothers. Never had my efforts to care for someone been met with so much misunderstanding, not to mention screaming. I began to wonder: Who are the one-anothers really not as we make them out to be, but as God's word presents them to us?

#### 1. They are part of the (global) church.

The New Testament Epistles contain most of the one-another commands. In them, "one another" refers to fellow believers. Consider Paul's first letter to the Corinthians, where the phrase appears five times. Long before he says, "Greet one another with a holy kiss" (1 Corinthians 16:20) - that is, with certain affection — he tells us he's talking to those sanctified in Christ Jesus, called to be saints together with all those who in every place call upon the name of our Lord Jesus Christ, both their Lord and ours. (1 Corinthians 1:2)

The command is not given to Christians, "to those sanctified in Christ Jesus, to apply to whomever they wish. Instead, Paul calls Christians to heed his words as "saints together." And he doesn't just mean the saints who live on nearby streets. He means "all those who in every place call upon the name of the Lord Jesus Christ."

Which means he's talking to me, and you, and the Christian in Kolkata, India. Were we ever to meet, the three of us are to greet one another as saints together, as those who call upon the name of the Lord Jesus Christ side by side, though several seas apart. Our mutual favor stems not from personal preference, but from our standing before God in Christ.

#### 2. They are a part of our (local) church.

"One another" ties all believers together, and then it anchors us in the local church. Look with me at a second one-another passage in 1 Corinthians: When you come together to eat [the Lord's Supper], wait for one another" (11:33). I imagine you and I (and especially our sister in Kolkata) do not stand in the same line for communion.

How do we respond? We aim this command indeed, every one-another! toward our local church in particular, the fellow believers in our weekly (even daily) midst. That's why Paul begins his letter by addressing the church of God that is in Corinth, to those sanctified in Christ Jesus, called to be saints together with all those who in every place call upon the name of our Lord Jesus Christ, both their Lord and ours. (1 Corinthians 1:2)


#### 3. They are every part of our church.

Even after we understand "one another" as fellow believers, and especially as those in our local church, we still often err while living out the commands. Whom do we gravitate toward, Sunday upon Sunday, after service? And whom do we seek out, almost exclusively, during the rest of the week? If the answer is only our dearest church friends, we have yet to hear the distinguishing mark of the one-anothers: love despite difference.

The words Scripture commands reflect the one Word pulsing behind its pages: Jesus. Apart from this Person, the one-anothers lack purpose and power. Upon whom does he lavish the one-anothers? Upon those like him, those he finds comfortable? Wonder of wonders, the answer is me. It's you. In a word, it's sinners. It's rebellious, undeserving men and women. It's fallen humans with whom the exalted Son of God had near nothing in common — that is, until he chose to humble himself, becoming one of us:

Though he was in the form of God, [he] did not count equality with God a thing to be grasped, but emptied himself, by taking the form of a servant, being born in the likeness of men. (Philippians 2:6-7)

It's no small task, going out of our way to love brothers and sisters unlike us, saints we may struggle to understand, sometimes even to like. But this is the love Christ has shown us, and his love empowers us to do the same for others. So may that love wash over any selfishness or natural inclination in us, and may we plunge our preferences into what brings him pleasure: showing his steadfast, widespread love to one another.
